

# NOMINATION FORM FOR STANDING COMMITTEE:

## ONE LAY MEMBER / TERM ENDING 2025

The 40<sup>th</sup> Convention will elect one Lay member for the Standing Committee for a term ending at Convention in 2025. Requirements for nomination: (1) The nominee must be at least 18 years old, (2) a Confirmed Adult Lay Communicant in Good Standing in this Diocese, (3) a resident in this Diocese for at least one year, and (4) as lay members from Emmanuel Memphis, St. Paul's Mason and Grace Paris are currently elected members of the Standing Committee, nominees may not be from any of these Faith Communities.

*Article IX of the Constitution*

### **Dates for Standing Committee Meetings:**

The SC will meet at 4 pm on the following dates in 2022: January 27, March 24, May 26, August 25, September 22 and October 27.

### **Description of Standing Committee Duties:**

- (1) The SC oversees the administrative and executive functions of this Diocese if there is no Bishop (Ecclesiastical Authority).
- (2) The SC serves as a Council of Advice to the Bishop.
- (3) The SC plays an integral role in determining the suitability of persons for ordination and other matters pertaining to clergy in this Diocese.
- (4) The SC must advise the Bishop and consent to the sale, lease or other encumbrance or alienation of property used solely for Divine Worship in this Diocese.

The nominator shall obtain the nominee's consent to nomination and certify their intent to serve, if elected, as indicated by the Nominee's signature at the bottom of this form. Nominations are to be submitted on separate forms along with bios of no more than 150 words, typed on a separate page, saved in Microsoft Word format and submitted by e-mail to diocese@episwtn.org. Nominations received by **October 5, 2021** will be included in the Convention Book. Additional nominations must be submitted prior to Noon the day of Convention.
