The 42nd Convention will elect one Clergy member of Bishop and Council for a four-year term ending at Convention in 2027. Requirements for nomination are (1) The nominee must be canonically resident and currently serving in ordained ministry in this Diocese, (2) 71 or younger unless the Bishop has extended his or her ministry in writing, (3) as clergy from Grace-St. Lukes, Holy Communion, and St. Mary's Episcopal School are currently elected members of Bishop and Council, nominees may not be serving at any of these Faith Communities. *Canon 9, Sec. 7 (b)*

Dates for Bishop and Council Meetings:

B&C will meet at 9 am on the following dates in 2024: January 26, April 25, May 23, August 22, September 26 and October 24. The Committee on Constitution and Canons has recommended increasing the number of meetings.

Description of Bishop and Council Duties:

- (1) B&C establishes policies and oversees the budgetary and programmatic business of this Diocese, similar to the role of a vestry/mission council of a Faith Community.
- (2) B&C establishes the policies and procedures of this Diocese.
- (3) B&C oversees implementation of the programs and priorities of The General Convention of The Episcopal Church.
- (4) No property of the Diocese or any Faith Community may be alienated, conveyed, transferred, encumbered, mortgaged, assigned, or leased without the prior consent of the Convention or of B&C.
- (5) B&C exercises powers of the Convention between meetings of the Convention.

The nominator shall obtain the nominee's consent to nomination and the nominee shall consent by signing below. A biography, including history of service in the church, of no more than 150 words shall also be submitted in Word format. Completed nomination forms (with biography) should be submitted by e-mail to salexander@episwtn.org. Nominations received by **5 p.m. on November 3, 2023**, will be included in the Convention Book. If not received by November 3rd, a fully completed nomination form must be submitted by email to salexander@episwtn.org no later than **November 16, 2023**.
