# **MINUTES**

of the

41st Annual Meeting of the Convention of the Episcopal Diocese of West Tennessee The Rt. Rev. Phoebe A. Roaf, Fourth Bishop of West Tennessee, Presiding

## Church of the Holy Communion and St. Mary's Episcopal School Memphis, Tennessee

Friday, November 18, 2022

#### **Morning Prayer**

The Convention began at 9:00 a.m. with a worship service of Morning Prayer, officiated by Bishop Roaf.

#### Call to Order

At 9:30 a.m. Bishop Roaf called the meeting to order. The Hon. Andy Cobb was appointed Parliamentarian. Mr. Steve Smith was appointed Secretary of Meeting. Canon Alisa Kelly was appointed Secretary of Elections.

#### **Certification of Quorum**

Secretary of the Meeting, Steve Smith, reported that 30 canonically resident clergy and 88 lay delegates were in attendance. To constitute a quorum a total of 25 canonically resident clergy and 42 lay delegates must be present. The Bishop declared a quorum present.

#### Welcome

A video message from Presiding Bishop Michael Curry was presented.

The Rev. Sandy Webb, Rector at Church of the Holy Communion, welcomed the attendees. An additional welcome was made by Albert Throckmorton, head of St. Mary's Episcopal School.

#### **Proposed Amendments to the Constitution of The Episcopal Church**

Proposed amendments to the Constitution of The Episcopal Church that were approved upon first reading at General Convention in 2022, and which will be presented for a second reading at General Convention in 2024, were presented by Parliamentarian Andy Cobb for information only with no action being required. The proposed amendments are shown on Page 11 of the Convention Booklet, which is attached as Exhibit A.

#### **Adoption of Order of Business**

After introductory remarks, Parliamentarian Andy Cobb moved to accept the Order of Business, no second being required. The motion was carried by voice vote. The Order of Business is shown on Page 3 of the Convention Booklet.

#### **Adoption of Minutes**

At the motion of Parliamentarian Andy Cobb, the minutes of the 40<sup>th</sup> Annual Meeting of the Convention of the Diocese of West Tennessee (Nov. 19, 2021) were adopted by voice vote.

#### **Adoption of Rules of Order**

After explaining the voting process and proposed changes to the Rules of Order, the Parliamentarian, on behalf of the Standing Committee on Constitution and Canons, presented Resolution WTN 2022-1 Amendments to Rules of Order. Resolution WTN 2022-1 was moved by the Standing Committee on Constitution and Canons and needs no second:

**Whereas,** at the 40<sup>th</sup> meeting of the Annual Convention of the Diocese in 2021 the Bishop requested that the Standing Committee on Constitution and Canons review the Rules of Order and propose updates and clarifications, and

Whereas, the Standing Committee on Constitution and Canons has performed the requested review and recommends that the amendments to the Rules of Order set forth on Attachment 1A to this Resolution be adopted by the Convention be adopted by the Convention; and

**Whereas,** an unmarked copy of the proposed Rules of Order is set forth on Attachment 1B for ease of reference by members of the Convention.

**Now, therefore, be it resolved** that the amendments to the Rules of Order set forth on Attachment 1A to this Resolution be, and hereby are, adopted by the Convention, with such amendments to become effective immediately upon adoption by the Convention.

The motion was approved by voice vote. A copy of the adopted Amendments to the Rules of Order is attached as <u>Exhibit B-1</u> and a copy of the Rules of Order as amended and in effect at Convention is attached as Exhibit B-2.

#### Amendments to the Constitution of the Diocese

On behalf of the Standing Committee on Constitution and Canons, the Parliamentarian introduced Resolution WTN 2022-2 Amendments to Constitution of the Diocese for a first reading. The Parliamentarian gave a brief explanation of the proposed changes. Resolution WTN 2022-2 was moved by the Standing Committee on Constitution and Canons and needs no second:

**Whereas**, at the 40<sup>th</sup> meeting of the Annual Convention of the Diocese in 2021 the Bishop requested that the Standing Committee on Constitution and Canons review the Constitution and Canons of the Diocese and propose updates and clarification, with a focus on reducing the size of the Standing Committee, Bishop and Council, Finance Committee, Commission on Ministry, and Standing Committee on Constitution and Canons, and

**Whereas**, the Standing Committee on Constitution and Canons has performed the requested review and recommends that the amendments to the Constitution of the Diocese set forth on Attachment 2A be adopted by the Convention; and

**Whereas**, an unmarked copy of the proposed Constitution is set forth on Attachment 2B for ease of reference by members of the Convention.

**Now, therefore, be it resolved** that the amendments to the Constitution set forth on Attachment 2A be, and hereby are, approved by the Convention, with such amendments to be submitted to the  $42^{\text{nd}}$  meeting of the Annual convention for adoption, and if so adopted, to become effective at 10:01 a.m. on January 1, 2024.

The motion was approved by voice vote. A copy of the Amendments to the Constitution (first reading) is attached as Exhibit C. The Amendments will be presented to the  $42^{nd}$  Diocesan Convention in 2023 for a second reading.

#### **Amendments to Canons of the Diocese**

On behalf of the Standing Committee on Constitution and Canons, the Parliamentarian introduced Resolution WTN 2022-3 Amendments to Canons of the Diocese. The Parliamentarian gave a brief explanation of the proposed changes. Resolution WTN 2022-3 was moved by the Standing Committee on Constitution and Canons and needs no second:

**Whereas**, at the 40<sup>th</sup> meeting of the Annual Convention of the Diocese in 2021 the Bishop requested that the Standing Committee on Constitution and Canons review the Constitution and Canons of the Diocese and propose updates and clarifications, with a focus on reducing the size

of the Bishop and Council, Finance Committee, Commission on Ministry, and Standing Committee on Constitution and Canons, and

Whereas, the Standing Committee on Constitution and Canons has performed the requested review and recommends that the amendments to the Canons of the Diocese set forth on Attachment 3A be adopted by the Convention; and

**Whereas**, an unmarked copy of the proposed Canons is set forth on Attachment 3B for ease of reference by members of the Convention.

**Now, therefore, be it resolved** that the amendments to the Canons set forth on Attachment 3A to this Resolution be, and herby are, adopted by the Convention, with amendments to Canons to become effective at 12:01 am on January 1, 2023; and

**Further resolved,** that the changes to the numbers of persons serving, the length of the terms of offices, and the classes of members contemplated by the amendments may be accomplished by any combination of methods the Bishop and Chancellor deem reasonable, including but not limited to requesting individuals to volunteer to shorten their terms or move to a class of members with a different term to fill a vacancy, choosing to not fill certain vacancies, electing fewer persons for classes of members at the next two or three Conventions, temporarily (for a period of not more than two years) allowing the board, council, commission or committee to have not more than two members more than permitted by the amended Canons so long as those members were already serving as member and cease to be voting members for the additional period of Time, or such other method as may be deemed reasonable by the Bishop and Chancellor.

#### Pre-Filed Amendment

The Rev. Sandy Webb presented a Pre-Filed Amendment to require that at least one member appointed to the Finance Committee be a member of the Clergy.

Upon motion duly made and seconded, and after discussion, the Pre-Filed Amendment was approved by voice vote.

There being no further discussion, Resolution WTN 2022-3 as amended was approved by voice vote. A copy of the Amendments (including the Pre-Filed Amendment) is attach as Exhibit D-1 and a copy of the Canons that will be effective at 12:01 am on January 1, 2023 is attached as Exhibit D-2.

Paul is past president of the Downtown Churches Association and member of the Memphis Christian Pastors Network. He is a tutor for Literacy Mid-South. Paul served on the Commission on Ministry in the Diocese of Kansas and Board of Trustees in the Diocese of Arkansas. Prior to ordination, his previous careers were in construction management and community development. Paul is married to Ruthie McLain, an attorney, who serves on the Standing Committee and Committee on Constitution & Canons and started Baseball with the Bishop!

Father Marx has served as a priest in this diocese since 1999, twenty-two of those years as rector of St. Andrew's.
