- 4. as lay members from St. John's Memphis and Holy Trinity Memphis currently serve on the Standing Committee, nominees may not be from any of these Faith Communities.

The SC will meet at 4 pm on the following dates in 2026: January 22, March 26, May 28, August 27, September 17 and October 22.

#### **Description of Standing Committee Duties:**

- 1. The Standing Committee oversees the administrative and executive functions of this Diocese if there is no Bishop (Ecclesiastical Authority).
- 2. The Standing Committee serves as a Council of Advice to the Bishop.
- 3. The Standing Committee plays an integral role in determining the suitability of persons for ordination and other matters pertaining to clergy in this Diocese.
- 4. The Standing Committee must advise the Bishop and consent to the sale, lease or other encumbrance or alienation of property used solely for Divine Worship in this Diocese.

The nominator shall obtain the nominee's consent to nomination and the nominee shall consent to the nomination by signing below. A biography, including the history of service in the church, of no more than 150 words, should be completed in the space at the end of this form.
